Regular Council Meeting 165 Broadway December 20, 2017 ~ 7:00 p.m. Meeting Minutes

Mayor Welsh called the meeting to order at 7:00 p.m., followed by the Pledge of Allegiance.

The Deputy Clerk read the public notice and roll call was taken, with the following persons in attendance:

A motion to approve the Regular and Executive meeting minutes of November 13, 2017 was made by Council President Ledrich and seconded by Councilman Mailley. *Motion was unanimously approved by voice vote.*

A motion to approve the reports, as submitted, was made by Councilman Murtaugh and seconded by Councilman Mailley. *The motion was unanimously approved by voice vote*.

ORDINANCE No. 13-2017 - An amended Ordinance authorizing the sale of land located within the Borough of Westville and known as Block 99, Lots 5 and 12 and execution of all necessary documents (Deadline Drive property)

Administrator Giles advised he spoke with Mr. Brewer and the process is moving forward and Mayor Welsh confirmed Solicitor Scaffidi is writing the contract.

A motion to open the meeting to the public was made by Councilman Murtaugh and seconded by Councilman Nordaby. *The motion was unanimously approved by voice vote.*

Public Hearing:

(Introduced November 13, 2017)

ORDINANCE No. 15-2017 - An Ordinance Amending Chapter 373, Vehicles and Traffic, Article XI. Schedules, Section 373-37.2 Schedule IXB: Four-Way Stop Intersections of the Borough of Westville Code Book (Vehicles and Traffic)

Mayor Welsh clarified that this Ordinance will allow the Borough to install a four-way stop sign at the corner of Olive & Cleveland Streets and Olive & Folsom Streets.

A motion to open the meeting to the public was made by Councilman Murtaugh and seconded by Councilman Nordaby. *The motion was unanimously approved by voice vote.*

Harold Ward, 321 W. Olive Street, asked about the traffic situation at Olive and Rt. 130 and was informed that Rt. 130 is a state road. Mayor Welsh advised Mr. Ward that Ordinance 16 (next for approval) may address his traffic concerns.

A motion to close the meeting to the public was made by Councilman Murtaugh and seconded by Councilman Mailley. *The motion was unanimously approved by voice vote.*

A motion to approve Ordinance No. 15-2017 was made by Councilman Murtaugh and seconded by Councilman Nordaby. *The motion was unanimously approved by roll call vote.*

Mayor Welsh confirmed with Administrator Giles that 20 days from the meeting date, the signs can be installed.

❖ ORDINANCE No. 16-2017 - Amending Chapter 373. Vehicles and Traffic, Article XI. Schedules, Section 373-29 Schedule I of the Borough of Westville Code Book - No Parking any time (Vehicles and Traffic)

Mayor Welsh confirmed parking will be permitted on Sunday mornings during Mass services. Solicitor Cornelius advised the Ordinance can be amended to allow parking during certain hours. Discussion took place about continued speeding on the street, even with the installation of the four way stop signs and no parking.

A motion to open the meeting to the public was made by Councilman Mailley and seconded by Councilman Nordaby. *The motion was unanimously approved by voice vote.*

Harold Ward, 321 W. Olive Street, asked about the traffic situation at Olive and asked about speed bumps. Discussion took place about the speeding on the street and the fact that the Police can track the traffic pattern.

A motion to close the meeting to the public was made by Councilman Nordaby and seconded by Councilman Sims. *The motion was unanimously approved by voice vote.*

Motion to rescind "closing the portion of the meeting to the public" to allow Susan Rodgers to speak was made by Councilman Nordaby and Council President Ledrich

Susan Rodgers, 100 Edgewater Avenue spoke about the snowmobile traffic on her street. Mayor Welsh asked Lt. Packer to speak with Ms. Rodgers after the meeting.
